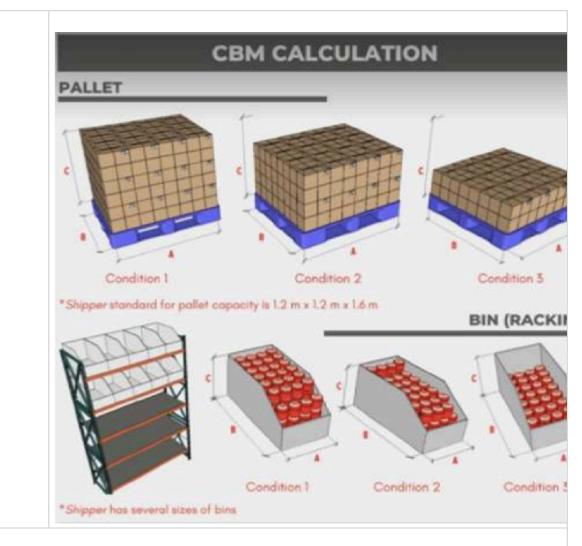

General Terms PT Pakde Solusi Digital (Pakde By Shipper)

- 1. Clients can only go live after LOA is signed.
- 2. Exceptions to go live without LOA imply possibility for account freeze if LOA is not signed within thirty (30) days of go live.
- 3. Taxes shall be applicable and tax rates may change in accordance with the applicable tax regulations.
- 4. The Invoice cycle is monthly
- 5. This proposal is non-binding and subject to the LOA
- 6. Shipper is not responsible for any illegal goods or unregistered distribution license from BPOM and/or related authorities which are being stored/transported by the Client through Shipper Warehouse and Fleet services. The consequences of any illegal act will have to be borne by the Client alone.
- 7. Client to release Shipper from all responsibilities when client can prove relevant certification of goods (including but not limited to BPOM, SNI, etc).
- 8. Shipper has the right to remove, destroy and/or dispose of goods that do not have a license / permit at the expense of the client.
- 9. Any medical testing including but not limited to Covid-19 (PCR/ Antigen, etc.) testing requirement for manpower is excluded from this proposal and is the Client's responsibility.
- 10. Shipper has the right to refuse any handling that does not follow the Shipper service standard or SLA as mentioned in the Scope of Work (including but not limited to oversized packages, oversized weight limits, etc.)
- 11. The charges associated with Loading and Unloading of Goods are excluded from the pricing mentioned in this proposal. If the loading/ unloading service is availed by the client, the TKBM charges shall be borne by Client as per the standard Shipper pricing for this service.
- 12. For offboarding, the freezing period is 2 days for final invoice calculation to the client.
- 13. Fulfillment price may change due to changes in Government Regulation. Shipper to give advance notice of at least 30 calendar days before the price increase becomes effective.
- 14. The Shipper Standards in the LOP is subject to update.
- 15. If client is using GMV model calculation and there is outbound request from client for any purposes, Shipper will charge that outbound as per GMV model calculation. If no price is found for some items, we will use Shipper outbound standard rate.
- 16. Pakde Solusi Digital provides warehousing services which is an object of withholding tax article
- 17. Shipper bears no responsibility for any special, incidental, indirect, or consequential damages of any kind whatsoever. These damages may include, but are not limited to, loss of business profit, business interruption, loss of business information, or any other financial loss. Regardless of the circumstances, Shipper's liability is strictly limited to its warehouse services.



Shipper Express Warehouse General Terms

- 1. Shipping rate is taken based on destination and dimension or weight of the package. In the event where dimension or weight is not matched with the data shared by client, actual rate will be used.
- 2. Additional charges will be applied for remote areas
- 3. Return is subject to additional fee and will be charged to the client.
- 4. Claims are only valid for a maximum of 7 days after receipt.
- 5. Claim does not apply if the damage is caused by the sender.
- 6. For **cashless shipment**, clients must provide Shopee Express and Lazada express shipping labels.
- 7. Shipping fee will be billed to the client in case of rejection by the recipient.
- 8. For international shipping, the price listed does not include custom (Bea cukai)
- 9. For international shipping, Airway Bill (AWB) will be updated after the goods arrive in Jakarta
- 10. For international shipping, the price listed does not include fuel surcharge, VAT and emergency surcharge
- 11. Client to provide all necessary documents related to the purpose of shipment (if required).
